## **AGENT ELIGIBILITY**

To qualify as an Agent, the following are mandatory:

- 1. Completion of the \$1.00 USD Agent Sign-Up Fee**
- 2. Submission of a valid PayNow Transaction ID**
- 3. Issuance of a unique Agent ID by the system**
- 4. Possession of an active PayNow account**

Agent IDs are issued once and must be kept secure.

## **SOFTWARE SALES MODEL**

- All software is sold as a ONE-TIME PURCHASE**
- Price range: USD \$12.00 – \$25.00**
- NO subscriptions**
- NO monthly or annual fees**
- Software is delivered offline where applicable**

**Agents are encouraged to sell software the same way  
airtime is sold:**

- Anywhere
- Anytime
- Direct to the customer

#### **AGENT COMMISSION STRUCTURE**

- Commission per completed sale: USD \$4.50
- Commission is earned only after confirmed payment
- All commissions are paid from the official  
Sentinel Nexus Systems bank account

**Agents are NOT authorized to retain client funds.**
